The Superintendent will be responsible for managing all functions of the job site for his/her assigned land development project(s) and will report directly to the Senior Project Manager.

Responsibilities:

- Manage all land development construction, including grading, wet utilities, streets, landscaping, walls, and amenities.
- Prepare, implement, manage, and update land development construction schedules.
- Assist with the management of land development budgets. Review, negotiate, and communicate trade change orders.
- Daily coordination of governmental officials, inspectors, consultants, and subcontractors to manage construction of projects in accordance with approved schedules.
- Assist with the creation of scopes of work for improvement projects based on plans, technical reports, existing and anticipated municipal regulations/requirements.
- Schedule and conduct contract and scope of work briefing meetings.
- Schedule and conduct pre-construction meetings with a variety of stakeholders (e.g. subcontractors, governmental agencies, utility companies, consultants, etc.)
- Build and maintain effective relationships with trade partners, inspectors, utility companies, internal team members, and other invested individuals.
- Monitor work production for compliance with construction schedule, scope of work, and adherence to industry workmanship standards.
- Assist with guest builder lot acceptance/turnover and daily coordination with their superintendents.
- ❖ Implement and manage all SWPPP measures and regulations.
- Coordinate inspections of completed improvements, completion of punch-lists, and exoneration of bonds.
- Identify and take advantage of opportunities to enhance project profit margins.
- Coordinate with all company staff including Senior Project Manager, Purchasing Agents, and Contract Administrators.
- Implement and manage company safety protocol in conformance with all regulatory requirements.

Requirements:

- 5 10 years of land development superintendent experience including mass grading, SWPPP, wet and dry utilities, concrete improvements, paving, masonry, landscaping, related civil and soils engineering.
- Vertical construction experience is a plus.
- Bachelor's degree in Construction Management, Civil Engineering, or related field preferred.
- SWPPP certification training and ability to read and review improvement plans, technical reports, contracts, and work scopes with a high degree of understanding.
- Ability to perform quality control review of all improvement plans and resolve conflicts ahead of construction.
- Proficient in Microsoft Office including Word, Excel, Outlook, and Microsoft Project.
